Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to enter into a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is an over the counter (OTC) contract – Interest Rate Instrument

Term

The maturity of this product is in 5 years. No party is entitled to terminate it unilaterally. Therefore, early termination of the contract is not possible.

Objectives

The purpose of this product is to give the seller of the cap the obligation to pay the difference between the floating rate and the Cap strike if the floating rate index on a given fixing date is higher than the strike rate. For this obligation the seller receives a premium.

The product involves the following cash flows:

The seller receives a premium when entering into the transaction.

At expiry: If the floating index rate is higher than the strike rate at a floating index rate fixing date, the party selling the Cap pays the difference between the floating index rate and the strike rate.

If the floating index rate equals or is lower than the strike rate, the party selling the Cap makes no payment.

The terms set out below are illustrative of the terms of an interest rate Cap. The exact terms are set out in each individual trade confirmation letter.

Intended retail investor

The product is intended for retail investors who:

- wish to hedge against adverse interest rate fluctuations, and have some participation in favorable exchange rate fluctuations
- intend to hold the product for the recommended investment horizon (throughout the term/until maturity)
- have knowledge and experience with this product
- are willing and able to bear losses
- do not need products with capital protection

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product until the agreed maturity date. You may not be able to cash in early. You may have to pay significant extra costs to cash in early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. We classify all OTC derivatives as being of the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact the capacity of DNB Bank ASA to pay you. In some circumstances you may be required to make further payments to pay for losses. The total loss you may incur may significantly exceed the amount invested. This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.
