This document provides you with key information about this product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

**You are about to enter into a product that is not simple and may be difficult to understand.**

## What is this product?

### Type

This product is an over the counter (OTC) contract – Interest Rate Instrument

### Term

The maturity of this product is in 5 years. No party is entitled to terminate it unilaterally. Therefore, early termination of the contract is not possible.

### Objectives

The objective of this product is to exchange floating interest payments based on an official interbank fixing rate (the interbank offered rate or NIBOR rate) against floating interest payments based on a swap fixing rate (the constant maturity swap rate or CMS rate) in the same currency and for an agreed tenor.

By entering into this Constant Maturity Swap, you will receive interest payments equivalent to the NIBOR from DNB on the settlement dates, provided that the NIBOR is fixed at a positive value. In return, you will pay DNB a floating CMS rate on the settlement dates.

If NIBOR or CMS rate is fixed at a negative value, the interest payment will be negative.

### Intended retail investor

The product is intended for retail investors who:

- wish to hedge against adverse interest rate fluctuations, and have some participation in favorable exchange rate fluctuations
- intend to hold the product for the recommended investment horizon (throughout the term/until maturity)
- have knowledge and experience with this product
- are willing and able to bear losses
- do not need products with capital protection

## What are the risks and what could I get in return?

### Risk indicator



The risk indicator assumes you keep the product until the agreed maturity date. You may not be able to end your product early. You may have to pay significant extra costs to end your product early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. We classify all OTC derivatives as being of the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact the capacity of DNB Bank ASA to pay you. In some circumstances you may be required to make further payments to pay for losses. The total loss you may incur may be significant. This product does not include any protection from future market performance so you could incur significant losses. If we are not able to pay you what is owed, you could incur significant losses.
