## Purpose

This document provides you with key information about this product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

## What is this product?

### Type

This product is an over the counter (OTC) contract – Interest Rate Instrument

### Term

The maturity of this product is in 5 years. No party is entitled to terminate it unilaterally. Therefore, early termination of the contract is not possible.

### Objectives

The purpose of this product is to manage the risk of unfavourable interest rates up to maturity of the product.

The buyer of the product has the right to receive the difference between the floating rate (STIBOR) and the Cap Strike applied to the notional amount in the product currency. If the floating rate is lower than the Floor Strike the holder of the product is obliged to pay the difference between the Floor strike and the floating rate applied to the notional of the product in the product currency. Depending of the level of the Cap strike and the Floor strike, the buyer of the product may receive a premium, pay a premium, or no premium is applied.

The product involves the following cash flows:

The payment is calculated on the basis of a pre-agreed amount (notional amount) and the duration of the relevant period according to the interest calculation method. The notional amount is neither paid by you nor by DNB, but serves for the purpose of calculation only.

The Key Information Document does not contain information related to your specific trade in the product, and is intended only as an example.

## What are the risks and what could I get in return?

### Risk indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. We classify all OTC derivatives as being of the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact the capacity of DNB Bank ASA to pay you. In some circumstances you may be required to make further payments to pay for losses. The total loss you may incur may be
