You are about to enter into a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is an over the counter (OTC) contract – Interest Rate Instrument

Term

The maturity of this product is in 5 years. No party is entitled to terminate it unilaterally. Therefore, early termination of the contract is not possible.

Objectives

The purpose of this product is to give the buyer of the Floor a right but not the obligation to receive the difference between the floating rate and the Floor strike if the floating rate index on a given fixing date is below the strike rate. For this right the buyer pays a premium.

The product involves the following cash flows:

At expiry: If the floating index rate is lower than the strike rate at a floating index rate fixing date, the party buying the Floor receives the difference between the floating index rate and the strike rate.

The terms set out below are illustrative of the terms of an interest rate Floor. The exact terms are set out in each individual trade confirmation letter.

Risk indicator

We have classified this product as 7 out of 7, which is the highest risk class. We classify all OTC derivatives as being of the highest risk class.
