## What is this product?

### Type

This product is an over the counter (OTC) contract – Foreign Exchange Instrument

### Term

The maturity of this product is in 12 months. No party is entitled to terminate it unilaterally. Therefore, early termination of the contract is not possible.

### Objectives

The purpose of this product is to give you as the buyer of an FX Call Option the right, but not the obligation to buy the notional amount of the Base Currency at a pre-defined price (strike price) on a pre-agreed date (settlement date). In return, you pay an option premium on the premium payment date. This FX Call Option is exercisable by the holder at the end of the trade tenor (expiry date).

If the spot rate for the Base Currency (FX spot rate) trades at or above the strike price on the expiry date, the holder will exercise the option, buy the Base Currency and sell the Price Currency at the strike price for the notional amount.

## What are the risks and what could I get in return?

### Risk indicator



The risk indicator assumes you keep the product until the agreed settlement date. You may not be able to cash in early. You may have to pay significant extra costs to cash in early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. We classify all OTC derivatives as being of the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact the capacity of DNB Bank ASA to pay you. This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.
