Purpose

This document provides you with key information about this product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to enter into a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is an over the counter (OTC) contract – Dual Currency Deposit (Flip Deposit)

Term

The maturity of this product is in 3 months. No party is entitled to terminate it unilaterally. Therefore, early termination of the contract is not possible.

Objectives

The purpose of the product is to give the investor the right and obligation to the outcome of the structure according to terms agreed in advance. This deposit is designed to provide the investor with a deposit rate in EUR which is above the money market level. In addition, the investor is exposed to the level of the EUR/SEK compared to the flip level at expiry. If the SEK depreciates against the EUR and is above the flip level, the investor receives back the deposit in SEK. If the EUR/SEK is below the flip level, the investor receives back the deposit in EUR.

The investor will participate in any price development in the underlying. In other words, the investor will profit if the currency being bought strengthens against the currency being sold, or lose in the event of an opposite development.

The product involves the following cash flows:

On the observation date:

- If the underlying appreciates, for example, where the exchange rate between investment currency and base currency is above the strike of 1 SEK = 10.9742 EUR, you will receive the accrued interest of 7.96 % p.a. in the investment currency and the principal amount (the investment amount), converted to base currency, at a previously agreed strike rate of 1 SEK = 10.9742 EUR.
- Otherwise, where the exchange rate between SEK and EUR is at or below the strike of 1 SEK = 10.9742 EUR, you will receive the investment amount plus the accrued interest of 7.96 % p.a. in the investment currency.

Settlement takes place only on the maturity date of the product, and if the investment currency appreciates significantly against the base currency, the investor might bear a significant potential loss due to the difference between the strike and the market price at the observation date. The valuation of the transaction depends on the market value of the underlying.

The amount invested is pledged for the entire duration of the product in order to guarantee any possible claim of the Bank.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product until the agreed settlement date. You may not be able to end your product early. You may have to pay significant extra costs to end your product early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity of DNB Bank ASA to pay you. **Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies.
