Purpose

This document provides you with key information about this product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to enter into a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is a forward contract linked to a future exchange rate (for example EURNOK in 12 months) where the investor buys foreign currency (EUR) and sells Norwegian kroner (NOK). The product can be used as protection against changes in the exchange rate.

Term

The forward contract runs for the period agreed between the parties (e.g. 12 months) from a start date to an end date. The parties have an obligation to exchange the agreed amounts in foreign currency and Norwegian kroner at the maturity of the product, regardless of the development of the exchange rate in the meantime.

Objectives

The purpose of the product is to give the investor the right and obligation to the outcome of the structure according to pre-agreed terms.

When the agreement is entered into, the amount, exchange rate and settlement date are agreed between the parties.

The investor will participate in any price development in the underlying. In other words, the investor will profit if the currency being bought strengthens against the currency being sold, or lose in the event of an opposite development.

The product involves the following cash flows assuming that the investor buys EUR and sells NOK:

On the maturity date, the investor will receive a predetermined amount in EUR in exchange for delivering a predetermined amount in NOK. In some cases the maturity date can be specified as an interval between two dates. The exchange ratio is determined by the agreed forward rate on the trade date.

The Key Information Document does not contain information related to your specific trade in the product, and is intended only as an example.

Intended retail investor

The product is intended for retail investors who:

- intend to hold the product for the recommended investment horizon (throughout the term/until maturity)
- have knowledge and experience with this product
- are willing and able to bear losses

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product until the agreed settlement date.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

You may not be able to end your product early. You may have to pay significant extra costs to end your product early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. We classify all OTC derivatives as being of the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact the capacity of DNB Bank ASA to pay you. **Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies.
