You are about to enter into a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is an over the counter (OTC) contract – Foreign Exchange Instrument

Term

The maturity of this product is in 12 months. No party is entitled to terminate it unilaterally. Therefore, early termination of the contract is not possible.

Objectives

The purpose of the product is to give the investor the right and obligation to the outcome of the structure according to terms agreed in advance. When the agreement is entered into, the amount, maximum rate, barrier rate and settlement date are agreed between the parties.

The investor will participate in any price development in the underlying. In other words, the investor will profit if the currency being sold strengthens against the currency being bought, or lose in the event of an opposite development.

The product involves the following cash flows:

If the FX spot rate is below the minimum rate you have sell the Base Currency and buy the Price Currency at the minimum rate. If the FX Spot is trading above the barrier rate on the expiry date, you are obliged to sell the Base Currency and buy the Price Currency at the minimum rate. If the spot rate is between the minimum rate and the barrier rate, you will sell the Base Currency at the current exchange rate.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product until the agreed settlement date. You may not be able to end your product early. You may have to pay significant extra costs to end your product early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. We classify all OTC derivatives as being of the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact the capacity of DNB Bank ASA to pay you.
