You are about to enter into a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is an over the counter (OTC) contract – Foreign Exchange Instrument

Term

The maturity of this product is in 12 months. No party is entitled to terminate it unilaterally. Therefore, early termination of the contract is not possible.

Objectives

The purpose of the product is to give the investor the right and obligation to the outcome of the structure according to terms agreed in advance. When the agreement is entered into, the amount, maximum rate, barrier rate and settlement date are agreed between the parties. The investor will participate in any price development in the underlying. In other words, the investor will profit if the currency being bought strengthens against the currency being sold, or lose in the event of an opposite development. The product involves the following cash flows:

If the FX spot rate is above the maximum rate you have the right to buy the Base Currency and sell the Price Currency at the maximum rate. If the FX Spot is trading below the barrier rate on the expiry date, you are obliged to buy the Base Currency and sell the Price Currency at the maximum rate. If the spot rate is between the maximum rate and the barrier rate, you will buy the Base Currency at the current exchange rate.
