Purpose

This document provides you with key information about this product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to enter into a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is an over the counter (OTC) contract – Foreign Exchange Instrument

Term

The maturity of this product is in 12 months. No party is entitled to terminate it unilaterally. Therefore, early termination of the contract is not possible.

Objectives

The purpose of the product is to give the investor the right and obligation to the outcome of the structure according to terms agreed in advance. When the agreement is entered into, the notional amount, maximum amount, bonus rate, barrier rate and expiration date are agreed between the parties.

The investor will participate in any price development in the underlying. In other words, the investor will profit if the currency being sold weakens against the currency being bought, or lose in the event of an opposite development.

The product involves the following cash flows:

If the spot rate trades above the lower barrier rate at expiry of the respective period without touching or rising above the bonus rate, you will have the right to sell the Base Currency amount at the bonus rate. If the spot rate trades at or above the level of the bonus rate at expiry of a period, you can multiply the Base Currency amount you can sell with Ratio Factor and sell this increased amount of the Base Currency at the bonus rate. If the spot rate trades at or below the barrier, no exchange rate will be secured.

Risk indicator
