You are about to enter into a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is an over the counter (OTC) contract – Foreign Exchange Instrument

Term

The maturity of this product is in 12 months. No party is entitled to terminate it unilaterally. Therefore, early termination of the contract is not possible.

Objectives

The purpose of the product is to give the investor the right and obligation to the outcome of the structure according to terms agreed in advance.

When the agreement is entered into, the amount, exchange rates, and settlement dates are agreed between the parties.

The investor will participate in any price development in the underlying. In other words, the investor will profit if the currency being bought strengthens against the currency being sold, or lose in the event of an opposite development.

The product involves the following cash flows:

If the FX spot rate is trading below the strike rate on the expiry date, you are obliged to buy the Base Currency and sell the Price Currency at the strike rate for the partial amount. The partial amount will be less than the hedge amount, so you might choose to sell additional amounts at the prevailing FX spot rate.

The risk indicator assumes you keep the product until the agreed settlement date. You may not be able to end your product early. You may have to pay significant extra costs to end your product early.

We have classified this product as 7 out of 7, which is the highest risk class. We classify all OTC derivatives as being of the highest risk class.
