## What is this product?

### Type

This product is an over the counter (OTC) contract – Foreign Exchange Instrument

### Term

The maturity of this product is in 12 months. No party is entitled to terminate it unilaterally. Therefore, early termination of the contract is not possible.

### Objectives

The purpose of this product is to give you as the seller of an FX Put Option the obligation to buy the notional amount of the Base Currency at a pre-defined price (strike price) on a pre-agreed date (settlement date). In return, you receive an option premium on the premium payment date. This FX Put Option is exercisable by the buyer at the end of the trade tenor (expiry date).

If the spot rate for the Base Currency (FX spot rate) trades at or below the strike price on the expiry date, the holder will exercise the option. You, as the seller, will buy the Base Currency and sell the Price Currency at the strike price for the notional amount.

## What are the risks and what could I get in return?

### Risk indicator

We have classified this product as 7 out of 7, which is the highest risk class. We classify all OTC derivatives as being of the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact the capacity of DNB Bank ASA to pay you.
