Purpose

This document provides you with key information about this product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to enter into a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is an over the counter (OTC) contract – Foreign Exchange Instrument

Term

The maturity of this product is in 12 months. No party is entitled to terminate it unilaterally. Therefore, early termination of the contract is not possible.

Objectives

By entering into an FX Risk Reversal, you acquire the right to trade a quantity of the Base Currency (notional amount) at a pre-defined price (Lower Strike Price) on a pre-agreed date (settlement date). In return, you acquire the obligation to trade a quantity of the Base Currency (notional amount) at another pre-defined price (Upper Strike Price) under certain circumstances.

If the spot rate for the Base Currency (FX spot rate) trades at or above the Upper Strike Price at the end of the trade tenor (expiry date), you have the right but not the obligation to sell the Base Currency and buy the Price Currency at the Upper Strike Price for the notional amount.

If the FX spot rate trades below the Upper Strike Price and above the Lower Strike Price on the expiry date, you may choose to sell the Base Currency and buy the Price Currency at the prevailing FX spot rate.

If the FX spot rate trades at or below the Lower Strike Price on the expiry date, you will be obliged to sell the Base Currency and buy the Price Currency at the Lower Strike Price for the notional amount.

Intended retail investor

The product is intended for retail investors who:

- ii) intend to hold the product for the recommended investment horizon (throughout the term/until maturity)

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product until the agreed settlement date. You may not be able to end your product early. You may have to pay significant extra costs to end your product early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. We classify all OTC derivatives as being of the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact the capacity of DNB Bank ASA to pay you. In some circumstances you may be required to make further payments to pay for losses. The total loss you may incur may be significant. This product does not include any protection from future market performance so you could incur significant losses. If we are not able to pay you what is owed, you could incur significant losses.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The scenarios shown are illustrations based on results from the past and on certain assumptions. Markets could develop very differently in the future.

How long should I hold it and can I take money out early?

Recommended Holding Period: 12 months
