You are about to enter into a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is an over the counter (OTC) contract – Foreign Exchange Instrument

Term

The maturity of this product is in 12 months. No party is entitled to terminate it unilaterally. Therefore, early termination of the contract is not possible.

Objectives

The purpose of the product is to give the investor the right and obligation to the outcome of the structure according to terms agreed in advance. When the agreement is entered into, the amount, exchange rates, and settlement dates are agreed between the parties.

The investor will participate in any price development in the underlying. In other words, the investor will profit if the currency being bought strengthens against the currency being sold, or lose in the event of an opposite development.

The product involves the following cash flows:

Under this FX Swap, you buy EUR on the initial exchange date. In return, you sell NOK on the initial exchange date; the exchange of the respective notional amounts takes place at the agreed spot rate. On the final exchange date, you sell EUR. In return, you buy NOK; the exchange of the respective notional amounts takes place at the agreed forward rate.

The Key Information Document does not contain information related to your specific trade in the product, and is intended only as an example.

Risk indicator
