You are about to enter into a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is an over the counter (OTC) contract – Interest Rate Instrument

Term

The maturity of this product is in 10 years. No party is entitled to terminate it unilaterally. Therefore, early termination of the contract is not possible.

Objectives

The purpose of the product is to give the investor the right and obligation to the outcome of the structure according to terms agreed in advance. When the agreement is entered into, the notional amount, time period, interest basis (floating rate) and fixed rate are agreed.

The investor will participate in any price development in the underlying. In other words, the investor will profit if the interest rate paid gets cheaper relative to the interest rate received, or lose in the event of an opposite development.

The product involves the following cash flows:

The purpose of this product is to exhange floating interest payments for fixed interest payments for an agreed period of time. The fixed rate payer will each period pay the fixed rate and receive the floating rate, where the cash flows are netted such that there is only one net cash flow for each interest rate period.
