This document provides you with key information about this product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to enter into a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is an over the counter (OTC) contract – Interest Rate Instrument

Term

The maturity of this product is in 5 years. No party is entitled to terminate it unilaterally. Therefore, early termination of the contract is not possible.

Objectives

The purpose of this product is to manage the risk of unfavourable interest rates up to maturity of the product.

The buyer of a Receiver Swaption has the right but not the obligation to enter into a receiver swap at the exercise date of the swaption. For this right, the buyer pays a premium. If the prevailing fixed rate of the underlying swap is lower than the swaption strike at the expiration of the swaption, the owner of the swaption will exercise its right to enter into a receiver swap with the fixed rate equal to the swaption strike.

The product involves the following cash flows:

Initially the buyer pays the seller a premium. The premium can also be amortised over a pre determined period.

If the current fixed rate of the underlying swap is lower or equal to the strike of the swaption, the buyer will exercise its right to enter into a payer swap with a fixed rate equal to the swaption strike.

Risk indicator

We have classified this product as 7 out of 7, which is the highest risk class. We classify all OTC derivatives as being of the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact the capacity of DNB Bank ASA to pay you. In some circumstances you may be required to make further payments to pay for losses. The total loss you may incur may be
