Purpose

This document provides you with key information about this product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to enter into a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is an over the counter (OTC) contract – Interest Rate Instrument

Term

The maturity of this product is in 5 years. No party is entitled to terminate it unilaterally. Therefore, early termination of the contract is not possible.

Objectives

The purpose of this product is to manage your interest rate and currency exposure.

The product periodically exchanges fixed or floating interest rate payments and potentially repayments of the notional amount in the base currency for fixed or floating interest rate payments and potentially repayments of the notional amount in the price currency from the start date until the end date.

At the inception of the product the underlying reference rate, the notional in domestic currency, the notional in foreign currency, the fixed rate, the time to maturity, the payment frequency (payment periods) and the trade price are agreed between the parties.

The cash flows of the product are as follows:

On the trade date you will pay the notional in the base currency and you will receive the notional in the price currency. Some Cross Currency Swaps can also be entered into without the initial exchange of notional.

On each payment date you will pay a fixed amount. The fixed amount is the product of the notional amount in the base currency and the fixed rate applied to the payment period. In return you receive a floating amount on each payment date. The floating amount is the product of the notional amount in the price currency and the floating reference rate applied to the payment period. The floating reference rate is determined 2 business days prior to each payment period.

On maturity you will receive the remaining notional in the base currency and you will pay the remaining notional in the price currency.

The Key Information Document does not contain information related to your specific trade in the product, and is intended only as an example.

Intended retail investor

The product is intended for retail investors who:

Risk indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact the capacity of DNB Bank ASA to pay you. In some circumstances you may be required to make further payments to pay for losses. The total loss you may incur may be significant.
