

# Key Information Document

## FX Put Option buy EUR GBP 2 month



### Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

**You are about to purchase a product that is not simple and may be difficult to understand.**

### What is this product?

**Type:** OTC - Derivatives contract (OTC means over the counter and indicates that the transaction is not executed on a trading platform).

**Term:** The maturity date (expiration date) of the product will be agreed upon when entering the FX Put Option buy EUR GBP 2 month contract, with the intention of holding the FX Put Option buy EUR GBP 2 month until the maturity date.

#### Objectives:

**Purpose:** An FX Put Option buy EUR GBP 2 month is used to limit the risk of an unfavourable fluctuation in exchange rate of the currency you would like to buy.

*When you enter into an FX Put Option buy EUR GBP 2 month with us some of the elements that are agreed upon are as follows:*

- The amount of currency you can buy
- The amount of currency you sell
- The exchange rate of the FX Put Option buy EUR GBP 2 month ('strike')
- The reference exchange rate that will be compared to the strike ('fixing')
- The date and time at which the exchange rate applicable at that moment is fixed and compared to the strike ('expiry date')
- The date upon which you may receive the purchased currency ('end date')
- The amount of the one-off premium payment that needs to be paid to Rabobank upfront.

**Method:** With an FX Put Option buy EUR GBP 2 month you purchase the right to buy currency at the expiry date at the strike. For example when you buy a Put EUR, you buy the right to buy GBP against an agreed amount in EUR. At the expiry date it will be determined whether your option has any value.

*This can lead to the following outcomes:*

- If at the expiry date, the exchange rate applicable at that moment is equal to or more favourable to you than the strike, the option will not be automatically exercised. You can buy the currency at the exchange rate applicable at that moment yourself; you profit from this rate if it is more favourable than the strike.
- If at the expiry date, the exchange rate applicable at that moment is less favourable to you than the strike, the option will be automatically exercised. By exercising the FX Put Option buy EUR GBP 2 month you buy the amount of currency at the strike. You will not have any downside from the exchange rate applicable at that moment.

In this Key Information Document it is assumed that the strike is equal to the exchange rate of that date (we call this the at-the-money strike).

**Return:** If the FX Put Option buy EUR GBP 2 month is not exercised you will lose your paid premium and your return will be negative. If the FX Put Option buy EUR GBP 2 month is exercised your return will be determined by the exchange rate difference between the strike and the exchange rate applicable at that moment minus the paid premium.

**Termination:** You can always end the FX Put Option buy EUR GBP 2 month unless you have agreed otherwise with Rabobank. For more information on the effects of ending please read the section 'How long should I hold it and can I take money out early?'. The FX Put Option buy EUR GBP 2 month can be unilaterally ended or adjusted by Rabobank. This is only possible in the situations described in the Financial Derivatives Agreement (FDA).

The amounts and other details in this document are used for indicative purposes. The calculations assume a notional amount of EUR 10,000, EUR/GBP as the currency pair and a term of 2 months. These details probably differ from the ones in your agreement with Rabobank. The example is for illustrative purposes only.

### Intended retail investor:

To make use of this product, you are required to be a Rabobank client and you must have been given access to the product. The product description should be read in advance, so that you understand how this product works and understand the risks. Additionally, we expect

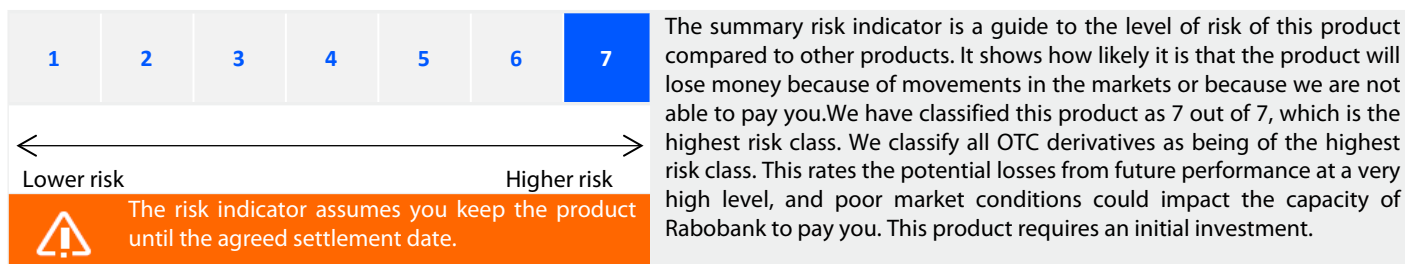
you to understand the concept of hedging risks and how this product can be used for hedging. Moreover, you should understand which factors influence the price of a contract (such as time to expiration, volatility, time value of money and notional amount). You should also understand the basis of currency-, interest rate-, liquidity- and country risk. Furthermore, you should understand how market value is established, and that this product is a bilateral contract between you and Rabobank.

This product must be used for hedging purposes only; you may hedge up to a maximum of 100% of the underlying risk. The maximum time to expiration is three years; a transaction with a time to expiration longer than two years requires approval by Rabobank. With this product you are minimizing currency risk by having the right to buy or sell the notional amount at the predetermined exchange rate and date. As such, you do not profit nor experience negative effects from future exchange rate fluctuations. You may lose 100% of the invested amount; in certain cases you may lose more.

The recommended holding period for the FX Put Option buy EUR GBP 2 month is equal to the duration of the underlying risk. In our example we use 2 months for this period.

### What are the risks and what could I get in return?

#### Risk indicator



**Be aware of currency risk.** You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

#### Performance scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The scenarios shown are illustrations based on results from the past and on certain assumptions. Markets could develop very differently in the future.

\* The potential return is calculated as the net profit or loss as a percentage over the notional amount.

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. This product cannot be easily ended. If you exit the investment earlier than the recommended holding period you may have to pay extra costs.

#### What happens if Rabobank is unable to pay out?

When Rabobank is not able to meet its obligations, the payments to be made by Rabobank are not covered by the Dutch Investor Compensation Scheme (beleggerscompensatiestelsel) or any other government or private protection scheme or guarantee. This means you could incur a significant loss.

#### What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed:

- Recommended Holding Period: 2 months
- You would get back the amount that you invested (0% annual return).
- 10,000 EUR is invested.

### How long should I hold it and can I take money out early?

In our example we use 2 months for this period. The FX Put Option buy EUR GBP 2 month is intended to hold until the end date in order to hedge the currency risk. The end date will be agreed with you.

The product cannot be ended; however, you can always enter an opposite transaction. By doing this you enter a new opposite transaction. The tenor of this new transaction equals the remaining term of the original transaction.
