## Interest Rate Swap with Floor at 0% 10 year

### Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

**You are about to purchase a product that is not simple and may be difficult to understand.**

### What is this product?

**Type:** OTC - Derivatives contract (OTC means over the counter and indicates that the transaction is not executed on a trading platform).

**Term:** The maturity date (expiration date) of the product will be agreed upon when entering the Interest Rate Swap with Floor at 0% 10 year contract, with the intention of holding the Interest Rate Swap with Floor at 0% 10 year until the maturity date.

#### Objectives:

**Purpose:** An Interest Rate Swap with Floor at 0% 10 year is used to change a floating interest rate for a fixed interest rate, whereby the floating interest rate cannot be negative. This Floor prevents you from having to pay this variable interest at a negative reference rate and from having to pay more than the fixed interest rate.

This product consists of two components: The Interest Rate Swap and the purchased Floor at 0%.

*When you enter into an Interest Rate Swap with Floor at 0% 10 year with us some of the elements that are agreed upon are as follows:*

- The fixed interest rate ('swap rate')
- The start and end date of the Interest Rate Swap with Floor at 0% 10 year
- The date and the periods for which the floating interest rate will be fixed
- The interest rate which is used as reference ('reference rate')
- The notional of the Interest Rate Swap ('notional')

**Method:** For each period you will receive the floating interest amount from Rabobank. In exchange you pay the fixed interest rate amount to Rabobank. Both will be calculated over the notional. The floating interest rate is fixed for each period at predetermined dates and at a predetermined reference rate. The most used reference rate is Euribor. Euribor rates are set and published every day. Relative to the Interest Rate Swap without Floor you have the additional agreement that when the floating interest rate will be negative (lower than 0%) there will be no (additional) payment from you to Rabobank.

*This can lead to amongst others the following outcomes:*

- You receive a nett amount if the floating interest rate is higher than the swap rate amount. Rabobank will pay you the difference between the two, or
- You pay a nett amount if the floating interest rate is lower than the swap rate amount. You will pay Rabobank the difference between the two, or
- If the floating rate is negative (below 0%), you only pay Rabobank the swap rate amount.

In this Key Information Document we chose for a constant notional during the tenor and the 3 months Euribor as a reference rate.

**Return:** The sum of the settlements of interest rate paid and received by you during the duration of the product.

**Termination:** You can always end the Interest Rate Swap with Floor at 0% 10 year unless you have agreed otherwise with Rabobank. For more information on the effects of termination please read the section 'How long should I hold it and can I withdraw money earlier?'. An Interest Rate Swap with Floor at 0% 10 year can be unilaterally ended or adjusted by Rabobank. This is only possible in the situations described in the Financial Derivatives Agreement (FDA).

The amounts and other details in this document are used for indicative purposes. The calculations assume a notional amount of EUR 10,000 and a term of 10 years. These details probably differ from the ones in your agreement with Rabobank. The example is for illustrative purposes only.

### Intended retail investor:

To make use of this product, you are required to be a Rabobank client and you must have been given access to the product. The product description should be read in advance, so that you understand how this product works and understand the risks. Additionally, we expect you to understand the concept of hedging risks and how this product can be used for hedging. Moreover, you should understand which factors influence the price of a contract (such as time to expiration, volatility, time value of money and notional amount). You should also

understand the basis of currency-, interest rate-, liquidity- and country risk. Furthermore, you should understand how market value is established, and that this product is a bilateral contract between you and Rabobank.

This product must be used for hedging purposes only; you may hedge up to a maximum of 100% of the underlying risk. The maximum time to expiration is three years; a transaction with a time to expiration longer than two years requires approval by Rabobank. With this product you are minimizing currency risk by having the right to buy or sell the notional amount at the predetermined exchange rate and date. As such, you do not profit nor experience negative effects from future exchange rate fluctuations. You may lose 100% of the invested amount; in certain cases you may lose more.

The recommended holding period for the Interest Rate Swap with Floor at 0% 10 year is equal to the duration of the underlying risk. In our example we use 10 years for this period.

### What are the risks and what could I get in return?

 The risk indicator assumes you keep the product until the agreed maturity date.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. We classify all OTC derivatives as being of the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions could impact the capacity of Rabobank to pay you. This product requires an initial investment.

In some circumstances you may be required to make further payments to pay for losses. **The total loss you may incur may significantly exceed the amount invested.** This product does not include any protection from future market performance so you could incur significant losses. If we are not able to pay you what is owed, you could incur significant losses.

#### Performance scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The scenarios shown are illustrations based on results from the past and on certain assumptions. Markets could develop very differently in the future.

#### What happens if Rabobank is unable to pay out?

When Rabobank is not able to meet its obligations, the payments to be made by Rabobank are not covered by the Dutch Investor Compensation Scheme (beleggerscompensatiestelsel) or any other government or private protection scheme or guarantee. This means you could incur a significant loss.

#### What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed:

- Recommended Holding Period: 10 years
- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
- 10,000 EUR is invested.

### How long should I hold it and can I take money out early?

In our example we use 10 years for this period. The Interest Rate Swap with Floor at 0% 10 year is intended to hold until the end date in order to hedge the currency risk. The end date will be agreed with you.

The product cannot be ended; however, you can always enter an opposite transaction. By doing this you enter a new opposite transaction. The tenor of this new transaction equals the remaining term of the original transaction.
